This puppy is being sold as a pet only, under no circumstances is this puppy/dog to be used for breeding unless otherwise arranged and/or agreed upon with the BREEDER.

Health Guarantee Terms:

Please initial that you have read and understand each item.

BREEDER guarantees that this puppy is in good health, up-to-date on all age appropriate immunizations and worming treatments.

_____ BUYER has the right to return the Puppy to the BREEDER within seven (7) days after transfer, for a refund of purchase price, if the Puppy is found by a licensed Veterinarian to be suffering from any life-threatening illness disease. Puppy must be examined by the BUYERS Vet within three (3) days of pick up. Proof of examination and diagnosis must be provided to the BREEDER.

_____ BUYER must notify Seller within seven (7) days of diagnosis of any problems found by their veterinarian through the post-purchase examination. Proof of examination and diagnosis must be provided to the Seller.

_____ If the Buyer fails to notify Seller within (7) days, both Buyer and Seller agree that the puppy was in good health at the time of transfer.

_____ The BREEDER promises to make the BUYER aware of any and all known health issues before the purchase of this puppy. The Breeder is not liable for any accident or injury of the animal once it leaves the BREEDER'S premises. Once the puppy leaves our care, we have very little control over how the puppy is handled, where the puppy is taken or what the puppy is exposed to. The BREEDER guarantees that the Puppy is free of hereditary defects to the best of our knowledge and any known health issues will be disclosed before purchase. A Warranty is provided for one (1) year after the birthdate of this Puppy for any hereditary debilitating disease that would cause the dog to lose quality of life before the age of five (5). Written proof must be provided by an approved Licensed Veterinarian. The Seller would pay Veterinary expenses up to half the purchase price. Proof of expenses and payments to a Licensed Veterinarian must be provided. The BREEDER reserves the right to a second veterinary opinion. The BREEDER shall be contacted immediately with the name and number of the vet responsible for performing the exam. The vet will also need to provide in writing all of the results and a formal diagnosis.

_____ The BUYER agrees to maintain this puppy/dog in good health, provide routine preventative health care, including but not limited to, inoculations, treatment for internal and external parasites, and preventative medications. BUYER agrees to provide fresh water and proper quality food in the correct amounts. If any of the above preventative care has not been provided, health warranty will be rendered null and void.

_____ BUYER understands that allowing the Puppy to become overweight, over-vaccinated or failure to provide Puppy with an adequate diet, exercise or proper veterinarian care will void the Health Guarantee.

_____ Death due to injury, accident, owner neglect or any other cause out of BREEDER'S control will not be eligible for a refund. BREEDER is not responsible for injuries sustained, illnesses contracted or death after transfer of ownership to BUYER.

_____ This contract does not cover the following: viral illnesses, parasites, infections, improper bites, viral giardia or coccidiosis or kennel cough. It also does not cover illnesses due to the ingestion of foreign objects,

food, chemicals, stress related issues, behavioral issues, physical injuries and/or illnesses which may have occurred and/or contracted during or after transport to the BUYER.

_____ **Spay & Neuter Agreement:** This puppy is being sold as a pet and companion and not for breeding purposes. The BUYER agrees to spay/neuter their puppy no later than 12 months of age and no earlier than 6 months of age. BUYER to provide written notice of this to the BREEDER. The BUYER also affirms that their purchase is for a “pet home” only and not for breeding purposes. If the purchased puppy is used to produce a litter, the BREEDER will be entitled to be compensated for breach of contract. The BUYER then agrees to pay the BREEDER an additional \$3000 above the purchase price. The general health guarantee as well as the genetic guarantee becomes void if the spay/neuter contract is violated.

_____ Rehoming: If for any reason, you are unable to care for your puppy or adult dog – PLEASE contact BREEDER immediately. We will assist in relocating your puppy into a new ‘approved’ home. Although we will not reimburse you for the original purchase price of the puppy/dog – we guarantee to assist you in placing them into a new loving home.

_____ Under no circumstances shall BREEDER be liable to the BUYER or to any third party for any consequential, incidental, or special damages resulting from or in any manner related to the dog.
